Bidders should prepare responses as simply and economically as possible, providing a concise description of the Bidders' ability to meet the requirements contained herein.

JEA reserves the right to evaluate the submittals, to waive any irregularities therein, and to reject any and all submittals should the team deem it in JEA's best interest to do so. The pre-qualification of bidders does not imply that any bid submitted by a pre-qualified bidder automatically qualifies that bid as a "competitive, "responsive," or a "satisfactory" bid.
